

**Section 25.08**

**Performance Guarantees**

To ensure compliance with this ordinance and any conditions imposed or approvals granted under this ordinance, the planning commission, City Council, ZBA, or Development Services Department may require that a performance guarantee be provided in the form of a cash deposit, certified check, irrevocable bank letter of credit, for a bank located in Wayne County, acceptable to the City covering the estimated cost of improvements associated with a project. The guarantee shall comply with the following:

- (a) The performance guarantee shall be in the amount specified by the site compliance schedule as adopted by the City Council.
- (b) The performance guarantee shall be deposited with the Development Service Department at the time of the issuance of the permit authorizing the activity or project.
- (c) As a condition for the issuance of a performance guarantee, the City shall establish in writing with a copy provided to the depositor an expiration date which allows reasonable time for completion of required improvements. Failure to complete improvements within the allotted time period shall cause forfeiture of that portion of the guarantee required to complete improvements if the City must take actions necessary to complete the improvement. The date of expiration for completion of all improvements may be extended in time for good cause shown. The performance guarantee shall be returned based upon completion of improvements and upon certification by the Development Services Department that the improvements are satisfactorily completed. There shall be an additional administrative fee payable to the City in an amount set by City Council resolution to cover the City's administrative costs.
- (d) At the request of the depositor, and the approval of the Development Services Department, the City shall rebate cash deposits in reasonable proportion to the ratio of work completed on the required improvements as work progresses. The City shall retain twenty five (25%) of the estimated cost of landscaping for one (1) year to ensure survival of landscaping for the first growing season and any necessary replacement.

REQUIREMENTS FOR LETTERS OF CREDIT (Performance Guarantee)**

The Building Department administers this requirement and will not issue a building permit without a letter of credit per the Planning Commission's requirement.

The Letter of Credit must be irrevocable, and made out to the City of Taylor. It should reference the particular site either by address or legal description, identifying both the amount and items specified, by the Planning Commission. The Letter of Credit should state, "Partial Drawings are Not Permitted". Finally, it should be for a long enough term to allow for the completion of the project. Twelve (12) to eighteen (18) months is generally more than enough time to complete the site work.

If, the bank issuing the Letter of Credit requires a Sight Draft for the cashing of the bank's letter of credit, then a template of the required form of the draft must be provided to the City of Taylor when the Letter of Credit is issued to the City.

Once the City has been notified that all work has been completed and has verified such, a letter is sent to the bank releasing the letter of credit. Letters are generally released within one to two weeks after notification.

If site work is not completed one month prior to expiration, the Letter of Credit should be extended, since the City would cash rather than allow a letter to expire for an incomplete project. The period of this extension should allow sufficient time to complete the project.
