**JURY INFORMATION:**

This is a juried art show. Applicants are selected based on originality and quality of workmanship. The jury is comprised of three professionals who have expertise in a broad spectrum of fine arts and fine crafts along with two staff members. All decisions by the jury are final.

Jury fee is no longer required.

**ENTRY REQUIREMENTS:**

All work must be the artist's own and must qualify as "fine art or fine craft." The Art in the Park Committee reserves the right to ask for the removal of objectionable or misrepresented items from the festival. You must provide three photos of your work and one photo of your booth display. The Art in the Park Committee reserves the right to use submitted photos for publicity purposes.

**BOOTH INFORMATION:**

A booth fee of \$75 for a 10x10 space or \$150 for a 10x20 space is required. A booth fee of \$85 for a 10x10 or \$170 for a 10x20 is required for all late applicants. Booth spaces are subject to availability.

**RETURNING ARTISTS:**

Artists previously accepted in 2008 do not have to send new photos if already on file and no changes are being made to booth or artwork.

**ARTISTS' REGULATIONS:**

Artists must be present, set up and ready to sell each day by the designated time and stay until the conclusion of the festival - *no exceptions*.

Booth sharing or subletting is not permitted. Booth assignments are at the sole discretion of the Art in the Park Committee.

All booths and their contents must be furnished by the artists and fit within the booth space.

Each exhibitor is responsible for collection and payment of the 6% Michigan Sales Tax. Contact the Department of Treasury in Lansing for more information or speak with your accountant.

All participating artists must appear with their work for the entire show - *no exceptions*. Booth sitters are available at the festival.

All work must be priced and for sale. Commercially produced merchandise is not allowed for exhibit or sale in this show. Final interpretation of the commercial status will be determined by the Art in the Park Committee.

The Art in the Park Committee strives to maintain a very high standard for this fine arts and fine crafts festival and will jury accordingly.
