**Plan Review Service Fee Schedule (PRSFS) and Building Valuation Data Table (BVD)**

For buildings with an estimated construction value up to \$3,000,000.00, the Building Plan Review fee is 0.0012 of the estimated value (\$250.00 minimum), \$3,000,000.00 to \$6,000,000.00 the fee is \$3,600.00 plus 0.0005 of the estimated value over \$3,000,000.00.

The Building Plan Review and Permit fees will be based on the estimated construction value calculated in accordance with the International Code Council's Square Footage Construction Costs Table (gross area x Square Foot Construction Cost). The table known as the Building Valuation Data Table is established and printed at least twice annually by the International Code Council (ICC). The schedule in effect at the ICC's web site ([www.iccsafe.org/cs/techservices](http://www.iccsafe.org/cs/techservices)) will be the table utilized for present and future calculations. Projects where it is not feasible to determine the construction value using the Building Valuation Data Table will have the construction value set by the Director of Building and Safety. The Director's decision can be based on executed contracts, the BVD Table, other similar projects or other engineer or architects estimates. The Director's decision will be final.

Hazmat-Mat releases and/or chemical spills beyond the immediate control of one City of Taylor Fire Company. Technical rescue events or events requiring the use of a Special Response Team, or additional resources beyond the normal scope of operations. MVA response with extensive or prolonged operation. **Minimum Water Bill**

The minimum water bill shall consist of sewer meter charge and water meter charge; consumption charges for water, sewer disposal charges, non-residential user fee and Ecorse Creek user charge based on actual water usage.

**Delinquent Accounts**

Customers who fail to pay their bi-monthly service bill shall be charged a 10% penalty based on the current charges only.

Delinquent accounts being transferred to the tax roll shall be charged a fee equal to 15% of the amount being transferred.

**Water Service Connection**

**Short Tap**

A short tap shall be considered any service connection on a street to a main on the same side of the street as the building or on site.

**Long Tap**

A long tap shall be considered any service connection installed on a main located across the street from the building.

**Long Tap Without Copper**

A long tap without copper is an alternative selected by the builder and/or owner who elects to perform the boring and installation of the copper service under the street, rather than having the Water Department do so. The Water Department will make the necessary connection of the furnished copper line to the water main and to the building service line.

All service connections of two (2) inches or less shall be furnished and installed by the City of Taylor Department of Public Works, Water & Sewer Division from the water main to the property line. All service connections of more than two (2) inches shall be installed by a private contractor subject to the inspection and approval of the City. The cost of the water meter must be paid at the time the tap permit is paid.

Water and Sewer Tap Fees may be adjusted by the Director of Water and Sewer under special or unusual circumstances. Service installations may be deemed special or unusual based upon certain conditions, lot size, and/or types of structures, new or existing. Decisions will be based on factual information provided by the applicant and on site inspection of the property being serviced. The Director's decision will be final.
