**SECTION 1.** That Article 25.00, Administration and Enforcement, Section 25.01, Planning Commission, be amended as follows:

Section 25.01

## **Planning Commission**

The City of Taylor planning commission is created consisting of nine (9) members all of whom shall be appointed by the mayor, subject to approval by a majority vote of the members of city council elected and serving. The members may include the mayor, one of the administrative officials of the City selected by the mayor, and one member of the City Council, or any combination thereof, as ex-officio members and the remaining persons appointed shall represent different professions or occupations pursuant to Public Act 33 of 2008 (MCL 125.3801 et. seq.) as amended. The planning commission is vested with the powers and duties set forth in the Act together with the following responsibilities:

**SECTION 2.** Repeal. All ordinances and parts of ordinances in conflict with the provisions set forth herein are hereby repealed to the extent of such conflict.

**SECTION 3.** Savings Clause. Should any section, clause or phrase of this ordinance be declared by a Court of competent jurisdiction to be invalid, the declaration by said Court shall not affect the validity of this ordinance as a whole or any part thereof other than the part so declared to be invalid.

**SECTION 4.** Publication and Effective Date. This ordinance shall become effective upon passage by the City Council and publication of the ordinance in accordance with the Charter of the City of Taylor and the statutes of the State of Michigan.
